BADMINTON

1. RULES

The competition will be held in accordance with the rules of the International Badminton Federation (IBF).

2. EVENT

Team's Event.

3. TECHNICAL ORGANIZATION

The technical committee of the 24th IMT-GT Varsity Carnival will be responsible to the technical organization of the competition. The decision of this committee in all matters regarding the tournament shall be final.

4. LAW OF THE GAME

The competition shall be conducted in accordance with the current rules of the games as approved by the International Badminton Federation.

5. NUMBER OF PLAYERS

- 5.1 Each team shall consist of not more than 4 players (2 men and 2 women).
- 5.2 In a particular tie, each player is allowed to participate in a singles and mixed doubles match.

6. ATHLETE ATTIRE (Competition Shirt)

All doubles and team competitions, team members are required to wear matching shirt colors.

7. POINTS IN GROUP COMPETITION

7.1 Method of points awarded

Win : 1 point Lose : 0 point

- 7.2 If two (2) or more teams in the same group obtain an equal number of points then the ranking shall be decided on:
 - 7.2.1 Match for and against
 - 7.2.2 Sets for and against
 - 7.2.3 Games for and against in the ties among the teams having equal points.
 - 7.2.4 In the event of a tie again, then the team that has defeated its opponent shall be ranked higher.
 - 7.2.5 If the result is still tied, then a coin toss shall decide the winner.

8. THE TIE

- 8.1 Each tie shall be competed in the following order.
 - 8.1.1 Men's Single
 - 8.1.2 Women's Single
 - 8.1.3 Mix Double
- 8.2 Rally Points Scoring System by IBF has been adopted for a match that consists of the best of three (3) sets of 21 points.

9. ABONDENED MATCH

In the event of cancellation or unfinished matches due to unforeseen circumstances, the match shall be replayed, if possible. Otherwise, a toss of a coin shall decide the winner.

10. WALK-OVER AND WITHDRAWAL

- 10.1 In the tournament, should any team fail to turn up for a match 15 minutes after the scheduled time, the opposing team shall be awarded a walk-over.
- 10.2 If a team withdraws from the competition, then the points of the withdrawing team shall be null and void.

11. JUDGING THE EVENTS

The necessary technical officials, referees, judges, umpires, time keepers or inspectors for sport shall be appointed by the appropriate National Sports Organization of the host nation.

12. INTERPRETATION

In the interpretation of the laws of games or the rules governing the badminton tournament, if there is any disagreement, the English text shall be taken authoritative.

13. MATTERS NOT PROVIDED FOR

All matters not provided for in the rules shall be dealt with by the games organizing committee whose decision is final.
